

Subject: Use of the NHRA-MVC Traceability Hub for Pharmaceutical Product Traceability

As per Resolution No. 41 of the year 2017, and in accordance with the National Health Regulatory Authority (NHRA) Medicines Barcoding and Serialization Guideline; Kingdom of Bahrain; May 2019 Version 1.2,

The Bahrain National Health Regulatory Authority (NHRA) has contracted with MVC W.LL to establish and manage the "NHRA-MVC" Traceability Hub track and trace system for the Kingdom of Bahrain. The NHRA-MVC team will handle all track and trace system requirements, procedures, reporting specifications, including the registration sign-up process and fee requirements for all Invoicing Companies representing Manufacturers/MAHs.

All Invoicing Companies representing Manufacturers/MAHs are required to:

- Register in the NHRA-MVC Traceability Hub, which requires a signed Participation Agreement with NHRA-MVC, pay a one-time sign-up fee and pay the annual fee in support of Bahrain's traceability initiative by 1st January 2021.
- All Invoicing Companies representing Manufacturers/MAHs are required to be fully reporting traceability events no later than October 2021.
- All Invoicing Companies representing Manufacturers/MAHs are required to be compliant with Aggregation reporting requirements by 1st May 2022.
- A All Invoicing Companies representing Manufacturers/MAHs shall email the name of their contact person, their email address, their phone number and the names of the Manufacturers/MAHs that they represent, by 15th November 2020, to: nhra-mvc-support@rfxcel.com

The NHRA-MVC sign-up process, including the Participation Agreement and fee table, are available on the NHRA-MVC website. The One-time sign-up and annual fee are collected during the sign-up process at www.nhra-mvc.bh

Once processed, the NHRA-MVC team will assist all Invoicing Companies representing Manufacturers/MAHs through the traceability reporting process, to ensure that their systems have the ability to send appropriate GS1 standard data files to the NHRA-MVC Traceability Hub.

A series of webinars will be hosted by the NHRA-MVC team to explain the sign-up, fee payment, and onboarding process of the Traceability Hub.

How did you calculate my Initial Fee?

• Your fee is based on the Invoicing Company's 2019 CIF Invoice Price of the Agent as Recorded by NHRA & Customs in DUR (Drug Utilization Record)

What is Annual Turnover?

 Annual Turnover Amount the Invoicing Company's annual CIF* Invoice Price of the Agent as Recorded by NHRA & Customs in DUR (Drug Utilization Record) system database

<u>*CIF</u>(Cost, Insurance, Freight) A pricing term indicating that the cost of goods, insurance, and freight are included in the quoted price.



How will you calculate my Initial Fee if my company did not sell medicines to Bahrain in 2019?

- If you had no sales in 2019, you will need to contact us at <u>nhra-mvc-support</u> <u>@rfxcel.</u>com and request assistance from our Administrative team.
- You will need to provide the official Company Name and address, your GLN (if you have one); and your estimated sales (CIF) range for 2021.
- Our Administration team will calculate your initial fees and get your Company set up in the system so you can signup and pay the required fees.



What if my Company does not have a Global Location Number?

 The NHRA-MVC team will help you identify an alternate identification number for your company to use with the NHRA-MVC Traceability Hub. Please send an email to <u>nhra-mvc-support @rfxcel.com</u> and request assistance from our Technical team.

After Onboarding, Where Do the EPCIS Files Come From?

- The company that ships the physical product to the Kingdom of Bahrain will send the EPCIS events to the NHRA-MVC-Traceability Hub (rTH)
- This is accomplished through their Serialization Partner



Is Aggregation Required?

- Aggregation is not initially required. If you are already aggregating you can send the information to the Traceability Hub immediately as part of the EPCIS 1.2 events.
- <u>Circular No. (46) 2020</u> published November 11, 2020 states that All Invoicing Companies representing Manufacturers/MAHs are required to be compliant with Aggregation reporting requirements by 1st May 2022.
